The November Chamber meeting was held at the Three Forks City Hall. Call to Order: The meeting was called to order by Brooke.

Approval of Minutes: The October 2019 unapproved minutes were sent prior to the meeting, for review. Chuck motioned to approve the October 2019 meeting minutes, Karen seconded. All approved.

Treasurer Report: Reports were sent prior to meeting. Ranee reviewed the Profit & Loss, Budget vs. Actuals, and Balance Sheet. Expenses: PayPal - fees for 2019 membership \$11.74; Brooke Leugers - reimbursement for lunch meeting with Connie at the Iron Horse Café, \$27.00; US Post Office - 3 rolls of stamps for Elections, \$165.00; Main Street Office - Christmas Stroll Advertising, \$191.25; Craigslist- Job Posting for Executive Director, \$20.00; Main Street Office - Phone Book Postage, \$530.49; Brooke Leugers - reimbursement for MACE Conference, \$305.00; Three Forks Market – Fun Money Reimbursement, \$15.00; Three Forks Voice – BAH Ad & Executive Director Hiring Ad, \$83.80; Chuck Wambeke – reimbursement for lunch meeting, \$30.53; Payroll – Connie Hussung \$856.58, Katie LaLiberty \$260.80; Main Street Office – phone book printing \$2,423.68.

Tanya motioned to approve payment of expenses, Chuck seconded and the board approved.

Executive Secretary Report: Connie reported on the month of October. The month was spent focusing on general bookkeeping, filing, weekly bulletins, newsletter, and member/visitor correspondence. Hiring notices and meeting with Brooke to discuss position improvements and interviewing also took place, as well as updating approved by-law revisions for Board approved changes in membership levels. Additionally, Connie worked with the Special Events Committee on the Christmas Stoll. There were 37 calls received/returned, 122 emails, 0 visitor packets and 0 relocation packets sent, and 0 tent rentals. Currently there are 109 members in good standing. Today is Connie's last day with the Chamber. We wish her well in her future endeavors and thank her for her many years of service. **Website Administrator Report:**

Katie was unable to attend so Connie reported on her behalf that the majority of her time during the month of October was spent updating memberships online, promoting special events and creating a social media schedule for the Christmas Stroll. She also assisted in posting for the Executive Director position.

The Three Forks Fire Department has been chosen for the annual split of the Tree/Wreath auction proceeds. The auction, along with the raffle, will be held at V-42 Fitness this year.

New Business:

- Executive Director Position- Brooke discussed restructuring the position to extend to 32 hours per week at \$15.00 per hour. She hoping that eventually the position will take on the website and social media role, thereby eliminating the Website Administrator position. Additionally, she requested that the position take on the duties of the current Secretary and changing the Secretary Officer position to a Board position. A vote was taken in which there were 7 votes for the change and 3 against. The changes were approved and will be incorporated into the by-laws of the Chamber.
- 2020 Chamber Annual Dinner Brooke announced that the Lewis & Clark motel will not be able to host the dinner in 2020, so the Chamber is seeking options to hold the upcoming dinner.
