**Non-Chamber Vendor** - \$50.00 – (Please consider joining the Three Forks Chamber of Commerce.)

**Non-Chamber Food Vendor** - \$100.00 Saturday with the option of Friday set up for \$50.00.

**Non-Profit Vendor** - \$15.00

**Additional 10'x10' Space** - \$25.00 each
